

By clicking Accept it will be considered your signature on this document that you qualify and agree with these terms

The purpose of the <u>30 Day Member Agreement</u> is to allow animal hospitals to gain access to TVC's purchasing programs to see if our programs benefit your clinic before you commit to joining as a full Voting Participating Member. Your hospital will have 30 days to try out TVC suppliers and programs. You agree to the following:

- I agree in the next 30 days to consider at least 4 TVC vendors to see if they will save my clinic money. I also agree to accept a call from TVC to determine which vendors I should contact.
- Provide TVC a check within <u>35 days</u> of this agreement <u>if</u> you want to convert the membership to a TVC full Voting Participating Member. There is no penalty or anything owed during the trial period or at termination of this agreement. <u>If TVC does not receive a check for the membership fee, your access to TVC programs and savings will be terminated.</u>
- I will have a right to participate in TVC's purchasing programs for 30 days. I know I will have to comply with TVC's and the vendor's protocols and requirements.
- I will comply with the TVC NDA found on the TVC member's only website, and keep TVC/Vendor pricing and programs confidential and I cannot use this knowledge to negotiate with current TVC vendors or competitive vendors for 3 years.
- If I send TVC a check for the one time membership fee and it is received by TVC <u>within 35 days</u> of this agreement, and upon Board approval, I will become a TVC Voting Participating Member. <u>The receipt of the signed check is acknowledgement that I have read and agree to the TVC Voting Participating Member agreement and TVC's Bylaws, both found on the TVC member's only site.</u>
- A **lifetime** (one time) membership fee of **\$300.00** is required to convert this membership to a Voting Participating Member. If a check for the membership fee is **not** received within 35 days, the TVC Membership and all of its privileges are terminated. There is no penalty or anything owed To TVC or the Temporary Member at termination of this agreement.
- During the term of the 30 day Membership:
 - I will not have voting rights.
 - I will not have any rights to patronage rebates or income distribution.
- Either the 30 day Member or TVC can terminate this arrangement at any time.
- I am an independent veterinarian eligible to be a member: Qualifications.
 - Individuals or legal entities who are an independent veterinary practice holding (or owned primarily by individuals holding) a current and valid state license to practice veterinary medicine in the United States.
 - Is an individual Veterinarian practicing veterinary medicine, or, a legal entity with at least fifty-one percent (51%) ownership by a Veterinarian, or group of Veterinarians, or is owned, as a successor, by a descendant of a Veterinarian.
 - If a legal entity, such legal entity does not have part or all of its ownership traded on an exchange.
 - Is free of any equity ownership by or similar relationship with any manufacturer or supplier whose products or services are sold to current or potential Members.
